Giving to the Endowment Fund provides dedicated resources for sharing the unchanging GOOD NEWS with a rapidly changing world, building on the legacy of Beautiful Savior's faithful past and present.



ENDOWMENT BASICS

- 1 An endowment is a separate fund of the church that invests gifts and uses the income generated to make focused grants (distributions) to further Beautiful Savior's mission.
- 2 Gifts to an endowment are preserved and protected. They become the "principal" or "corpus" of the fund and are never distributed or spent down.
- 3 The accumulated investment earnings of the endowment corpus are used to fund strategic ministry opportunities on an ongoing basis.
- 4 All endowment funds are invested and professionally managed under a long-term investment strategy designed to produce a return that ensures the positive and perpetual impact of the endowment on Beautiful Savior's mission.

WAYS TO GIVE

Honor the Lord with your substance and with the first fruits of all your produce; then your barns will be filled with plenty, and your vats will be bursting with wine.

LIFETIME GIVING

These gifts are in addition to your current regular giving through offerings to the General Fund.

These gifts may be one-time gifts or gifts made in installments over a defined period of time.

These gifts may be made as a memorial for, or tribute to, a loved one.



LEGACY GIVING

These "planned gifts" are made by a donor through a will, trust, or estate plan. They are funded after the passing of the donor.

Most legacy gifts are a fixed dollar amount or percentage of an estate. They may include specific assets like stocks, bonds, other securities, real estate, or life insurance. Some gifts are made using retirement beneficiary designations or existing donor-advised funds.

Planned giving can be an important component of a donor's estate plan and tax planning. Consultation with your estate and tax advisors is highly recommended as you consider a gift.
